<p><i>Market Price customers are billed at the Hourly Ontario Energy Price (HOEP) plus Global Adjustment (GA). Customers who have signed a contract with an electricity retailer are billed at their contract price plus Global Adjustment.</i></p>						
<p style="text-align: center;"><b>GLOBAL ADJUSTMENT</b></p> <p style="text-align: center;">If you are paying HOEP or purchase electricity from a retailer, you will see a separate line item on your bill for Global Adjustment. The Global adjustment accounts for differences between the market price of electricity and the regulated or contract prices paid to generators for the electricity they produced. The Global Adjustment also includes the cost of the Independent Electricity System Operator's conservation and demand management programs.</p>						
<p>Global adjustment is calculated monthly by the IESO. It can be either a credit or a charge to consumers depending on fluctuations in the market price. (see <a href="http://www.ieso.ca">www.ieso.ca</a>)</p>
